Subject: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Company has received, on March 25, 2026, an Order dated March 24, 2026 from the Assistant Commissioner, Central GST and Central Excise, Division-Hingna, Nagpur-I.

The said Order has been passed under Section 74 of the Central Goods and Services Tax Act, 2017 ("CGST Act") demanding recovery of tax amounting to ₹72,13,794/- on account of alleged excess availment of Input Tax Credit (ITC) for the financial year 2019-2020. The Order further levies applicable interest under Section 50 of the CGST Act on the aforesaid tax demand and imposes a penalty of ₹72,13,794/- under Section 74 of the CGST Act.

The Company is currently evaluating the order and intends to challenge the proposed demand and penalty before the appropriate authority. Based on its assessment, the Company believes that the demand is not sustainable and will not have any material impact on its financial position, operations, or other activities.

The details, as required under Clause 20 of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No: SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 & SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is enclosed as Annexure A.
